CRITERIA

4. Philanthropic contribution or voluntary service.
5. Any other important contributions to community, state, or nation.
6. Serves as an unselfish example of leadership and integrity worthy of emulation by active Jaycees everywhere.

The Jaycees Hall of Leadership is located in The U.S. Junior Chamber Archives and Exhibition Hall in Tulsa, Oklahoma. PUBLICATIONS

Inductees will be recognized in the following issues of the *Jaycees Magazine* and a press release will be sent to hometown media as specified by the inductee.

INDUCTION CEREMONY

A formal presentation will be presented at the Hall of Leadership ceremony held in conjunction with The U.S. Junior Chamber's Ten Outstanding Young Americans (TOYA) Awards Banquet and Ceremony. All Hall of Leadership inductees will be expected to attend the ceremony.

NOMINATIONS

Inductees will be chosen by a review committee from nominations submitted by any U.S. Jaycees Foundation trustee, consultant, donor, state or local Jaycee President. Qualified nominators may submit more than one nominee per year.
